The competition may join a person, who fulfill the conditions laid down in the Law on Higher Education of 27 July 2005 (Dz. U. No 164, item. 1365), as amended and the Statute of the Nicolaus Copernicus University

Terms of employment: full time, first 3 year contract; beginning of employment on 10.01.2018., the candidate selected in the competition will be subject to regular periodic evaluations.

The successful candidate must have:

1. PhD degree in biological sciences or related
2. scientific achievements documented in publications in leading international journals
3. plan for further research activities
4. teaching experience
5. knowledge of the issues and methods in the field of botany, particularly molecular methods
6. desired experience in raising funds for research
7. desired foreign internships or visible international activity such as participation in international conferences, participation in international projects, cooperation with foreign partners documented by joint publications

9. Polish and English language skills sufficient to provide lectures and to write papers in English

Required documents:

2. Personal questionnaire for the person applying for employment
3. Professional curriculum vitae
4. Copy of doctorate (PhD) certificate
5. Information about scientific, didactic and organizational achievements (abstract comprising candidate's most important areas of research, and scientific, educational, and other achievements including plan for further research activities)
6. List of publications (including the publishing house, year of publication, and page number)
7. Declaration under art. 109 ust. 1 ustawy Prawo o szkolnictwie wyższym (o niekaralności) (Art. Paragraph 109 (1) of the Higher Education Act (of no criminal record))
8. Declaration that Nicolaus Copernicus University in Toruń will be my primary employer once I have won the contest.
9. Declaration of consent to the processing of personal data contained in the job offer for the needs of the recruitment process, in accordance with the Personal Data Protection Act dated 29.08.1997 (Journal of Laws of the Republic of Poland 2016, item 922)
